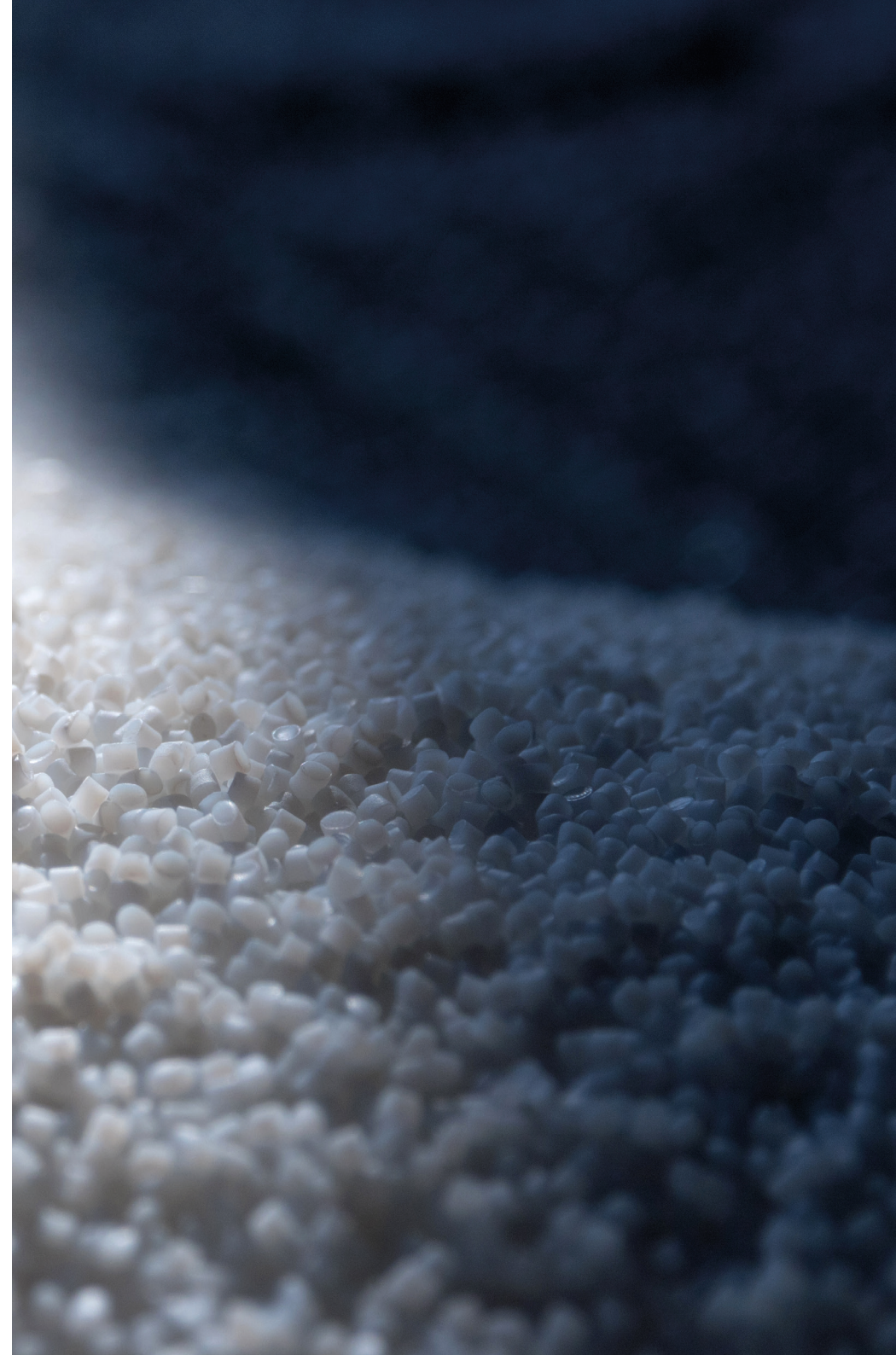
ABOUT NCT HOLLAND B.V.
